Concerning Copyright Restrictions

RULES FOR THE USE OF ETHNIC STUDIES LIBRARY ARCHIVES MATERIAL

PERMISSION TO USE: Permission to examine materials in the Archives and Photographic Collections will be granted to users who are at least 18 years old. Such permission granted is subject to whatever restrictions have been placed on specific holdings by their creators, donors, or the librarians of the Ethnic Studies Library. Permission to consult does not carry with it the permission to publish. In certain cases, users may be requested to use microfilm or printed copies of the manuscripts when such copies are available.

REGISTRATION: Users will complete a Reader Registration Form at the circulation desk and show identification. Briefcases, backpacks, envelopes, and other items must be checked in at the circulation desk. Laptops are allowed. Only pencil may be used in the designated area. No marks may be made on collection materials; annotations found in collection materials should not be removed.

RESPONSIBILITY: The user is responsible for the safeguarding of any materials made available to him/her and must preserve the existing order and arrangement of the archival materials. Suspected irregularities in arrangement should be brought to the attention of staff. Manuscript and other loose-leaf materials require special care; often additional time is needed to page and refile them. White gloves are provided and must be worn when handling unsleeved photographic materials.

DUPLICATION: Duplication of archival materials and reprinting of photographs must have the prior permission of the librarian in charge of the collection. All photocopies are to be handled by library staff and at the expense of the user. Library staff will photocopy a reasonable amount of materials (1-5 pages at 75¢ per page) for reference use when this can be done without injury to the material and when not otherwise restricted. No photocopies will be made of photographic materials.

Personal cameras may be used with the approval of staff and subject to copyright restrictions and concerns for the physical preservation of the original materials. Please refer to the **Policy for the Use of Personal Cameras in the Ethnic Studies Library** for specific guidelines.

Users may request high-resolution digital scans of original material and photographs from UC Berkeley's Digital Imaging Lab when this can be done without harm to the materials and when not otherwise restricted. Please request a **Photograph Services Information and Order Form** from library staff. On site filming or videotaping of archives and fragile materials (appointment and librarian approval required) will be charged at a \$300/hr. minimum. Prepayment is required for all photographic requests.

Copies of archive materials and reprints of photographs may not be reduplicated and deposited elsewhere without the prior written permission of the Ethnic Studies Library.
